Agreement between the Parish and Parents of Religious Education Students

What parents can expect from the Parish:

1. The program will be administered by an experienced professional Coordinator of Religious Education with certification in the field.
2. The parish priests will be actively involved in the program, visiting classrooms periodically.
3. Opportunities for the Sacrament of Reconciliation will be offered at least once a year.
4. Class size will be limited to 18 students if possible.
5. Every effort will be made to ensure that each teacher is capable, committed and trained.
6. The parish will ensure that classrooms and other teaching areas are clean, comfortable and safe.
7. A uniform and consistent discipline policy will be in place, to ensure that classes are not continually disrupted by uncooperative pupils.
8. The advice, comments and criticism of parents will be welcome at all times, and will be actively sought from time to time by the Coordinator, and by the Parish priests.
9. All adults involved in our Religious Education Program will have attended a Virtus Child Protection Workshop.

What the Parish expects from parents:

1. The process of Christian Initiation begins with Baptism, and continues with the child's reception of Reconciliation (Penance), First Communion and Confirmation. We expect that a child will begin formal religion classes at least by first grade (but preferably in preschool and kindergarten) and will attend each year until Confirmation.
2. Since the parish's role in religious education is meant to complement and fulfill the religious attitude and practice experienced with the family, we expect that minimally, the child is attending Mass regularly. We can postpone reception of the Sacraments until the child and parent resume regular attendance at Mass.
3. We expect that parents will support the religious education program by:
 - (a) Registering and paying program fees on time.
 - (b) Making sure that children attend each day.
 - (c) Notifying the Religious Education Office when a child needs to be absent, and contacting the teacher for make-up work.
 - (d) Talking with the child about his/her experiences in class.
 - (e) Keeping communication open when there is a problem or disruption that needs to be addressed.
